



ACP Participant Updates

General Election

If you aren't already a Protected Records Voter (PRV) and you want to vote in the upcoming general election, call us and we will send you a PRV form.

You will need to use your residential address when you fill out the PRV form so ACP personnel at the county can properly precinct your ballot.

It is important not to update your voting information online once you become a PRV. The privilege of being a PRV is that your information is not online in the VoteWA database.

If you have questions about the status of your ballot, call your county elections office and let them know you are in ACP. You will be connected with the staff who work with ACP participants.

If you receive a letter from the county asking about your ballot, respond right away to be sure your vote counts!

Presidential Primary

The Presidential Primary for 2024 will be in March. In this election you are required to choose a party affiliation on the ballot.

It is ONLY for this election that you will need to pick a party for your vote to count. You will not be registering with the party that is a separate process. Because you are in ACP your name WILL NOT go on any lists affiliating you with a party.

If you get a piece of mail that has a red stamp, like the one above and your PMB hand written on it, please take the time to contact the sender or business who sent you the mail and ask them to add your ACP PMB to your address. We know that there are some companies that can't/won't add the PMB to the address line. If that is the case, ask them to add your PMB number after your name.

The format for your address is:

If mail doesn't have a PMB number it may be delayed. If you share a name with another participant and we can't tell who should get the mail, we must return it.



Please remember to notify the ACP at least two (2) days before you move. We must have your address change in writing or by fax. For your safety, we don't take a change of address over the phone or by email. We don't know who is on the other end of the phone and our email is public record.

If your mail gets returned as undeliverable and we can't get in touch with you, we will cancel your participation in the ACP. Make sure the ACP has your current phone number and your voicemail is set up so we can contact you if there are any problems.
