

## Certificate of Lot Draw Results

Date: May 10 , 2024 Time: 6:00 pm

After the close of business on the last day for candidates to file for office, the filing officer shall determine by lot the order in which the names of those candidates will appear on all ballots. The determination shall be done publicly and may be witnessed by the media and by any candidate. If no primary is required for a race, the names of candidates in that race shall appear on the general election ballot in the order determined by lot. RCW 29A.36.131.

## Result of Lot Draw.

The candidate as filed will be assigned the ballot order according to the number drawn. The number removed from the capsule is the ballot order of the candidate in the applicable race.

## Witnesses:
