BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

<u>NEW SECTION.</u> Sec. 1. The people recognize that the use of tobacco products of all types is a significant public health problem. Cigarettes, cigars, and smokeless tobacco can lead to lifelong nicotine addiction. Cigar and cigarette smokers are at significant risk for oral, throat, and esophageal cancers. Smokeless tobacco products similarly raise users' risk of various diseases including cancers of the lip, tongue, cheeks, and gums.

NEW SECTION. Sec. 2. A new section is added to chapter 9.91 RCW to read as follows:

(1) It is unlawful to sell, manufacture, or possess any tobacco products including, but not limited to, cigarettes, cigars, and smokeless tobacco.

(2) A person who:

(a) Sells or manufactures any tobacco product is guilty of a classB felony punishable according to chapter 9A.20 RCW; or

(b) Possesses any tobacco product is guilty of a class C felony punishable according to chapter 9A.20 RCW.

(3) For the purposes of this section, "tobacco product" includes any product containing tobacco or nicotine that is expected or intended for human consumption.
