1 AN ACT Relating to health care financing; amending RCW 41.05.120,
2 41.05.130, 66.24.290, 82.24.020, 82.26.020, 82.08.150, 43.79.480, and
3 41.05.220; adding new sections to chapter 82.02 RCW; adding a new
4 chapter to Title 43 RCW; creating new sections; repealing RCW 82.04.260
5 and 48.14.0201; making an appropriation; providing effective dates; and
6 providing an expiration date.

7 BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** (1) There is a crisis in health care
9 accessibility, affordability, and choice in Washington state. Health
10 care through insurance companies has failed to control costs, increase
11 access, or preserve choice. More than six hundred thousand Washington
12 residents have no health care coverage. Individual plans are
13 unavailable in most counties. Many clinics, physician practices, and
14 emergency departments, especially in rural areas, are closing or
15 operating at a loss. Employers, faced with fewer choices and more
16 expensive premiums, are reducing employment-based health care coverage.
17 Simplifying health care financing and eliminating administrative waste
18 inherent in multiple insurance plans can create sufficient savings to

1 extend health care coverage to all residents and enhance fairness in
2 the system.

3 (2) The people of the state of Washington declare their intent to
4 create a framework and process to involve the citizens of Washington
5 state in the creation of a single financing entity called the
6 Washington health security trust. Through public hearings, research,
7 and consensus building, the trust will accomplish the follow goals:
8 (a) Provide fair, simple, and accountable health care financing for all
9 Washington residents using a single health care financing entity; (b)
10 cover a comprehensive package of effective and necessary personal
11 health services; (c) make health care coverage independent from
12 employment; (d) eliminate excessive administrative costs resulting from
13 the current fragmented system of multiple insurers; (e) generate
14 savings sufficient to ensure coverage for all Washington residents; (f)
15 integrate current publicly sponsored health programs into the health
16 security trust; (g) preserve choice of providers for Washington
17 residents; (h) protect patient rights; (i) keep clinical decisions in
18 the hands of health professionals and patients, rather than
19 administrative personnel; (j) promote health care quality; and (k)
20 control excessive health care costs.

21 NEW SECTION. **Sec. 2.** The definitions in this section apply
22 throughout this chapter unless the context clearly requires otherwise.

23 (1) "Board" means the board of trustees of the Washington health
24 security trust, created in section 3 of this act.

25 (2) "Capitation" means a mechanism of payment in which a provider
26 is paid a negotiated monthly sum and is obliged to provide all covered
27 services for specific patients who enroll with that provider.

28 (3) "Case rate" means a method of payment based on diagnosis. Case
29 rate assumes that a given set of services shall be provided and the
30 rate is based on the total compensation for those services.

31 (4) "Chair" means the presiding officer of the board.

32 (5) "Employer" means any person, partnership, corporation,
33 association, joint venture, or public or private entity operating in
34 Washington state and employing for wages, salary, or other
35 compensation, one or more residents.

36 (6) "Federal poverty level" means the federal poverty guidelines
37 determined annually by the United States department of health and human
38 services or its successor agency.

1 (7) "Group practice" or "group" means a group of practitioners
2 voluntarily joined into an organization for the purpose of sharing
3 administrative costs, negotiating with payers and controlling the
4 circumstances of their medical practice, and, in some cases, sharing
5 revenues. The group may be of a single specialty or include more than
6 one specialty.

7 (8) "Health care facility" or "facility" includes any of the
8 following appropriately accredited entities: Hospices licensed
9 pursuant to chapter 70.127 RCW; hospitals licensed pursuant to chapter
10 70.41 RCW; rural health care facilities as defined in RCW 70.175.020;
11 psychiatric hospitals licensed pursuant to chapter 71.12 RCW; nursing
12 homes licensed pursuant to chapter 18.51 RCW; community mental health
13 centers licensed pursuant to chapter 71.05 or 71.24 RCW; kidney disease
14 treatment centers licensed pursuant to chapter 70.41 RCW; ambulatory
15 diagnostic, treatment, or surgical facilities licensed pursuant to
16 chapter 70.41 RCW; approved drug and alcohol treatment facilities
17 certified by the department of social and health services; home health
18 agencies licensed pursuant to chapter 70.127 RCW; and such facilities
19 if owned and operated by a political subdivision or instrumentality of
20 the state and such other facilities as required by federal law and
21 implementing regulations.

22 (9) "Health care practitioner" or "practitioner" means a person
23 licensed or certified under Title 18 RCW or chapter 70.127 RCW, and
24 covered by the all categories of provider law, RCW 48.43.045, providing
25 health care services in Washington state consistent with their lawful
26 scope of practice.

27 (10) "Health care provider" or "provider" means any health care
28 facility, or health care practitioner or group practice licensed or
29 certified under Washington state law to provide health or
30 health-related services in Washington state.

31 (11) "Income" means the adjusted gross household income for federal
32 income tax purposes.

33 (12) "Long-term care" means institutional, residential, outpatient,
34 or community-based services that meet the individual needs of persons
35 of all ages who are limited in their functional capacities or have
36 disabilities and require assistance with performing two or more
37 activities of daily living for an extended or indefinite period of
38 time. These services include case management, protective supervision,

1 in-home care, nursing services, convalescent, custodial, chronic, and
2 terminally ill care.

3 (13) "Native American" means an American Indian or Alaska native as
4 defined under 25 U.S.C. Sec. 1603.

5 (14) "Payroll" means any amount paid to Washington state residents
6 and defined as "wages" under section 3121 of the internal revenue code.

7 (15) "Resident" means an individual who presents evidence of
8 established, permanent residency in the state of Washington, who did
9 not enter the state for the primary purpose of obtaining health
10 services. "Resident" also includes people and their accompanying
11 family members who are residing in the state for the purpose of
12 engaging in employment for at least one month. The confinement of a
13 person in a nursing home, hospital, or other medical institution in the
14 state may not by itself be sufficient to qualify such person as a
15 resident.

16 (16) "Trust" means the Washington health security trust created in
17 section 3 of this act.

18 NEW SECTION. **Sec. 3.** An agency of state government known as the
19 Washington health security trust is created. The purpose of the trust
20 is to provide coverage for a set of health care services for all
21 residents.

22 NEW SECTION. **Sec. 4.** (1) The trust shall be governed by a board
23 of trustees. The board consists of nine trustees selected for
24 expertise in health care financing and delivery, and representing
25 Washington citizens, business, labor, and health professions. The
26 initial trustees shall be appointed by the governor, subject to
27 confirmation by the senate. The governor shall appoint the initial
28 board by March 15, 2005. Of the initial trustees, three shall be
29 appointed to terms of two years, three shall be appointed to terms of
30 four years, and three shall be appointed to terms of six years.
31 Thereafter, trustees shall be elected to six-year terms, one trustee
32 from each congressional district; the first class of trustees shall be
33 elected from the first, second, and ninth congressional districts; the
34 second class from the third, seventh, and eighth congressional
35 districts; and the third class from the fourth, fifth, and sixth
36 congressional districts. The governor shall appoint a trustee to serve

1 the remaining term for a vacancy from any cause. The board shall
2 convene no later than May 15, 2005.

3 (2) Members of the board shall have no pecuniary interest in any
4 business subject to regulation by the board. Members of the board are
5 subject to chapter 42.52 RCW.

6 (3) The initial, appointed members of the board shall occupy their
7 positions on a full-time basis and are exempt from the provisions of
8 chapter 41.06 RCW. The elected trustees must occupy their positions
9 according to the bylaws, rules, and relevant governing documents of the
10 board. The board and its professional staff are subject to the public
11 disclosure provisions of chapter 42.17 RCW. Trustees shall be paid a
12 salary to be fixed by the governor in accordance with RCW 43.03.040.
13 Five trustees constitute a quorum for the conduct of business.

14 (4) One member of the board shall be designated by the governor as
15 chair, subject to confirmation by a majority of the other trustees.
16 The chair shall serve in this capacity, subject to continuing
17 confidence of a majority of the board.

18 (5) If convinced by a preponderance of the evidence in a due
19 process hearing that a trustee has failed to perform required duties or
20 has a conflict with the public interest, the governor may remove that
21 trustee and appoint another to serve the unexpired term.

22 NEW SECTION. **Sec. 5.** (1) Subject to the approval of the board,
23 the chair shall appoint two standing committees.

24 (a) A citizens' advisory committee shall have balanced
25 representation from health experts, business, labor, and consumers.
26 The citizens' advisory committee shall hold public hearings on
27 priorities for inclusion in the set of health services, survey public
28 satisfaction, investigate complaints, and identify and report on health
29 care access and other priority issues for residents.

30 (b) A technical advisory committee shall have members with broad
31 experience in and knowledge of health care delivery, research, and
32 policy, as well as public and private funding of health care services.
33 The technical advisory committee shall make recommendations to the
34 board on technical issues related to covered benefits, quality
35 assurance, utilization, and other issues as requested by the board.

36 (2) The board shall consult with the citizens' advisory committee
37 at least quarterly, receive its reports and recommendations, and then

1 report to the governor and legislature at least annually on board
2 actions in response to citizens' advisory committee input.

3 (3) Subject to approval of the board, the chair may appoint other
4 committees and task forces as needed.

5 (4) Members of committees shall serve without compensation for
6 their services but shall be reimbursed for their expenses while
7 attending meetings on behalf of the board in accordance with RCW
8 43.03.050 and 43.03.060.

9 NEW SECTION. **Sec. 6.** The chair is the presiding officer of the
10 board and has the following powers and duties:

11 (1) Appoint an executive director with the approval of the board.
12 The executive director, with approval of the board, shall employ staff
13 in accordance with chapter 41.06 RCW necessary to execute the policies
14 and decisions of the board;

15 (2) Enter into contracts on behalf of the board. All contracts are
16 subject to review and binding legal opinions by the attorney general's
17 office if disputed in a due process hearing by a party to such a
18 contract;

19 (3) Subject to explicit approval of a majority of the board, accept
20 and expend gifts, donations, grants, and other funds received by the
21 board; and

22 (4) Delegate administrative functions of the board to the executive
23 director and staff of the trust as necessary to ensure efficient
24 administration.

25 NEW SECTION. **Sec. 7.** (1) In general, the board shall:

26 (a) Establish and maintain an information system where information
27 on the health status of the state's population and the factors that
28 affect it can be collected, researched, and shared.

29 (b) Define the trust's vision, policies, goals, programs,
30 procedures, rules, guidelines, and benefits in accordance with the
31 trust's purpose as described in section 3 of this act.

32 (c) Negotiate to: (i) Assign roles to providers, suppliers, and
33 auxiliary persons and groups; (ii) make contracts with providers,
34 suppliers, and auxiliary persons and groups; (iii) obtain the necessary
35 federal and state waivers to fulfill the trust's purpose; and (iv)
36 integrate the trust's activities with those of other state agencies.

1 (d) Supervise resources: (i) By influencing the creation,
2 allocation, and disposal of trained personnel, facilities, equipment,
3 and supplies; and (ii) by managing the trust's finances through
4 budgeting, cost controls, and distribution of funds.

5 (e) Monitor the trust's performance and make necessary adjustments.

6 (2) In particular, subsection (1) of this section includes, but is
7 not limited to, the powers and duties enumerated in this subsection
8 (2). The board shall: (a) With advice from the citizens' advisory
9 committee and the technical advisory committee, establish and keep
10 current a set of health services to be financed by the trust, as
11 provided in section 11 of this act; (b) make the necessary decisions
12 for the trust to finance the set of health services for all residents
13 starting May 15, 2006; (c) develop policies to protect confidentiality
14 of patient records throughout the health care delivery system and the
15 claims payment system; (d) make eligibility rules, including
16 eligibility for residents temporarily out-of-state; (e) develop or
17 contract for development of a streamlined uniform claims processing
18 system that must pay providers in a timely manner for covered health
19 services; (f) develop appeals procedures for residents and providers;
20 (g) work with the citizens' advisory committee and the technical
21 advisory committee to develop effective measures to control excessive
22 and unnecessary health care costs; (h) address nonfinancial barriers to
23 health care access; (i) monitor population migration into Washington
24 state to detect any trends related to availability of universal health
25 care coverage; and (j) develop an annual budget for the trust.

26 (3) To the extent that the exercise of any of the powers and duties
27 specified in this section may be inconsistent with the powers and
28 duties of other state agencies, offices, or commissions, the authority
29 of the board supersedes that of such other state agency, office, or
30 commission.

31 NEW SECTION. **Sec. 8.** Beginning May 15, 2006, the board shall
32 adopt, in consultation with the office of financial management, an
33 annual Washington health security trust budget. Except by legislative
34 approval, each annual budget shall not exceed the budget for the
35 preceding year by more than the Washington state consumer price index.
36 If operations expenses exceed revenues generated in two consecutive
37 years, the board shall recommend adjustments in either benefits or
38 revenues, or both, to the legislature.

1 NEW SECTION. **Sec. 9.** (1) The board shall report annual changes in
2 total Washington health care costs, along with the financial position
3 and the status of the trust, to the governor and legislature at least
4 once a year.

5 (2) The board shall seek audits annually from the state auditor.

6 (3) The board shall contract with a private organization for an
7 external performance audit every two years.

8 (4) The board shall adopt bylaws, rules, and other appropriate
9 governance documents to ensure accountable, open, fair, effective
10 operations of the trust, including methods for electing trustees and
11 rules under which reserve funds may be prudently invested subject to
12 advice of the state treasurer and the director of the office of
13 financial management.

14 (5) The board shall submit any internal rules or policies it adopts
15 to the secretary of state. The internal rules or policies must be made
16 available by the secretary of state for public inspection.

17 NEW SECTION. **Sec. 10.** (1) All residents are eligible for coverage
18 through the trust.

19 (2) If a resident has health insurance coverage for any health
20 services provided in the state, the benefits provided in this act are
21 secondary to that insurance. Nonresidents are covered for emergency
22 services and emergency transportation only.

23 (3) Until federal waivers are accomplished, residents covered under
24 federal health programs shall continue to use that coverage, and
25 benefits provided by the trust shall extend only to costs not covered
26 by the federal health programs.

27 (4) The board shall make provisions for determining eligibility for
28 coverage for residents while they are temporarily out of the state.

29 (5) Pending integration of federally qualified Taft-Hartley trusts
30 into the health security trust, employees covered under Taft-Hartley
31 trusts are not eligible for coverage through the health security trust
32 unless: (a) The employee's salary is considered in calculating the
33 employer's health security assessment defined under section 16 of this
34 act; and (b) either the employer or the employee pays the health
35 security premium under section 17 of this act.

36 (6) Pending integration of federally qualified Taft-Hartley trusts
37 into the health security trust, residents who are retirees covered
38 under Taft-Hartley trusts are not eligible for coverage through the

1 health security trust unless they pay the health security premium under
2 section 17 of this act.

3 (7) Pending integration into the health security trust of
4 applicable federal programs described in section 21 of this act, native
5 American residents are not eligible for coverage through the health
6 security trust unless: (a) The native American resident's salary is
7 considered in calculating the employer's health security assessment
8 defined under section 16 of this act; and (b) either the employer or
9 the native American resident pays any health security premium due under
10 section 17 of this act.

11 (8) Nothing in this act shall be construed to limit a resident's
12 right to seek health care from any provider he or she chooses, or from
13 obtaining coverage for health care benefits in excess of those
14 available under the trust.

15 NEW SECTION. **Sec. 11.** (1) With advice from the citizens' advisory
16 committee and the technical advisory committee, the board shall
17 establish a single benefits package covering health services that are
18 effective and necessary for the good health of residents and that
19 emphasize preventive and primary health care.

20 (2) The benefits package shall include, but is not limited to: (a)
21 Inpatient and outpatient hospital care, including twenty-four hour a
22 day emergency services and emergency ambulance services; (b)
23 outpatient, home-based, and office-based care; (c) rehabilitation
24 services, including speech, occupational, and physical therapy; (d)
25 inpatient and outpatient mental health services and substance abuse
26 treatment; (e) hospice care; (f) prescription drugs and prescribed
27 medical nutrition; (g) vision and hearing care; (h) diagnostic tests;
28 (i) durable medical equipment; and (j) preventive care.

29 (3) Subject to a financial analysis demonstrating ongoing
30 sufficient funds in the trust, long-term care shall be a covered
31 benefit as of May 15, 2007. Long-term care coverage shall include a
32 uniform initial assessment and coordination between home health, adult
33 day care, and nursing home services, and other treatment alternatives.
34 The board shall establish a copayment for long-term nursing home care,
35 to cover some costs of room and board, for residents with incomes above
36 one hundred fifty percent of the federal poverty level. The board, in
37 coordination with the office of the insurance commissioner, shall

1 examine by May 15, 2007, possible remedies for residents who have made
2 previous payments for long-term care insurance.

3 (4) Except where otherwise prohibited by federal law, the board
4 shall establish copayments for outpatient visits, emergency room
5 visits, and prescription drugs for residents with incomes above one
6 hundred fifty percent of the federal poverty level. There shall be an
7 annual cap of five hundred dollars per family.

8 (5) The board shall submit to the legislature by July 1, 2007, a
9 plan to incorporate dental care coverage in the benefits package, to be
10 effective January 1, 2008.

11 (6) The board shall submit to the governor and legislature by
12 December 1, 2005, and by December 1st of the following years: (a) The
13 benefits package, and (b) an actuarial analysis of the cost of the
14 package.

15 (7) The board shall consider the extent to which medical research
16 and health professions training activities should be included in the
17 scope of covered activities set forth in this act. The board shall
18 make a report to the governor and the legislature by July 1, 2007.

19 (8) The board, in conjunction with the citizens' advisory committee
20 and the technical advisory committee, must study the feasibility of
21 medical savings accounts funded by a portion of each resident's health
22 security premium. If the board deems that such accounts are feasible
23 and would promote prudent use of health care services and reduce health
24 care costs to residents and the trust, then the board is authorized to
25 establish them.

26 NEW SECTION. **Sec. 12.** (1) When consistent with existing federal
27 law, the board shall require pharmaceutical and durable medical
28 equipment manufacturers to provide their products in Washington state
29 at the lowest rate offered to federal and other government entities.

30 (2) The board may seek other means of financing drugs and durable
31 medical equipment at the lowest possible cost, including bulk
32 purchasing agreements with Washington state tribes.

33 (3) The board may enact drug formularies that do not interfere with
34 treatments necessary for appropriate standards of care.

35 NEW SECTION. **Sec. 13.** (1) The board shall adopt rules permitting
36 providers to collectively negotiate budgets, payment schedules, and
37 other terms and conditions of trust participation.

1 (2) The board shall annually negotiate with each hospital and each
2 facility a prospective global budget for operational and other costs to
3 be covered by the trust. Group practices may also negotiate on a
4 global budget basis. Hospitals and other facilities shall be paid on
5 a fee-for-service or case rate basis, within the limits of their
6 prospective annual budget.

7 (3) Payment to individual practitioners shall be by fee-for-service
8 or on a case rate basis. The board shall study the feasibility of
9 paying by capitation to providers, and how resident enrollment would
10 take place under capitation.

11 (4) Individual practitioners who are employed by a group, facility,
12 clinic, or hospital may be paid by salary.

13 (5) The board shall adopt rules ensuring that payment schedules and
14 procedures for mental health services are comparable to other health
15 care services.

16 (6) The board shall study and seek to develop provider payment
17 methods that: (a) Encourage an integrated multispecialty approach to
18 disease management; (b) reward education time spent with patients; and
19 (c) include a medical risk adjustment formula for providers whose
20 practices serve patients with higher than average health risks.

21 (7) Nothing in this act shall be construed to limit a provider's
22 right to receive payments from sources other than the trust. However,
23 any provider who does accept payment from the trust for a service must
24 accept that payment, along with applicable copayments, as payment in
25 full.

26 NEW SECTION. Sec. 14. (1) The intent of this section is to exempt
27 activities approved under this act from state antitrust laws and to
28 provide immunity from federal antitrust laws through the state action
29 doctrine.

30 (2) Activities that might otherwise be constrained by antitrust
31 laws, including: (a) Containing the aggregate cost of health care
32 services; (b) promoting cooperative activities among health care
33 providers to develop cost-effective health care delivery systems; and
34 (c) any other lawful actions taken under this act by any person or
35 entity created or regulated by this act, are declared to be pursuant to
36 state statute and for the public purposes of the state of Washington.

1 NEW SECTION. **Sec. 15.** (1) Administrative expenses to operate and
2 maintain the trust shall not exceed eleven percent of the trust's
3 annual budget. The board shall not shift administrative costs or
4 duties of the trust to providers or to resident beneficiaries.

5 (2) The board shall work with providers to develop and apply
6 scientifically based utilization standards, to use encounter and
7 prescribing data to detect excessive utilization, to develop due
8 processes for enforcing appropriate utilization standards, and to
9 identify and prosecute fraud.

10 (3) The board may institute other cost-containment measures in
11 order to maintain a balanced budget. The board shall pursue due
12 diligence to ensure that cost-containment measures do not limit access
13 to clinically necessary care, nor infringe upon legitimate clinical
14 decision making by practitioners.

15 NEW SECTION. **Sec. 16.** A new section is added to chapter 82.02 RCW
16 to read as follows:

17 In addition to and not in lieu of taxes imposed at the rates
18 established under chapter 82.04 RCW, all Washington state employers
19 shall pay a health security assessment to the department of revenue to
20 fund the Washington health security trust created in section 3 of this
21 act.

22 (1) Effective May 15, 2006, all employers in Washington state shall
23 pay in quarterly installments a health security assessment. Except as
24 provided in this section, the health security assessment shall be: (a)
25 In the case of employers with a quarterly payroll under one hundred
26 twenty-five thousand dollars, zero percent of gross quarterly payroll;
27 and (b) in the case of employers with a quarterly payroll of one
28 hundred twenty-five thousand dollars or more, ten percent of the gross
29 quarterly payroll.

30 (2) For purposes of determining the tax rates under subsection (1)
31 of this section, the quarterly payroll threshold of one hundred twenty-
32 five thousand dollars must be adjusted annually by the office of
33 financial management to reflect changes in the Washington state
34 consumer price index.

35 (3) The department of revenue shall assess a penalty at the rate of
36 two percent per month, or a fraction thereof, on any employer whose
37 applicable health security payroll assessment is not postmarked by the
38 last day of the month following the quarter in which it is due.

1 (4) The federal government, when an employer of Washington state
2 residents, is exempt from the health security assessment prior to the
3 repeal, amendment, or waiver of existing state and federal laws
4 delineated in section 21 of this act.

5 (5) Beginning May 15, 2006, until May 15, 2011, employers that face
6 financial hardship in paying the health security assessment, may, upon
7 application to the board of trustees created in section 4 of this act,
8 be eligible for waivers or reductions in the health security
9 assessment. The board shall establish rules and procedures governing
10 all aspects of the business assistance program, including application
11 procedures, thresholds regarding firm size, wages, profits, age of
12 firm, and duration of assistance.

13 (6) Pending integration of federally qualified Taft-Hartley trusts,
14 the payroll of employees covered under these trusts is exempt from the
15 health security assessment, although the employer may pay it
16 voluntarily.

17 (7) Pending repeal, amendment, or waiver of applicable state and
18 federal laws delineated in section 21 of this act, payroll of native
19 American residents who elect not to participate in the health security
20 trust is exempt from the health security assessment.

21 (8) Eighty percent of the revenue collected under this section must
22 be deposited in the benefits account created in section 24 of this act.

23 (9) For the purposes of this section, the terms "employer,"
24 "payroll," and "resident" have the same meaning as defined in section
25 2 of this act.

26 NEW SECTION. **Sec. 17.** A new section is added to chapter 82.02 RCW
27 to read as follows:

28 (1) Effective May 15, 2006, all Washington residents eighteen years
29 and older, except medicare beneficiaries, with incomes over one hundred
30 fifty percent of the federal poverty level shall pay a health security
31 premium of seventy-five dollars per month.

32 (2) Medicare beneficiaries with incomes over one hundred fifty
33 percent of the federal poverty level shall pay a health security
34 premium of fifty dollars per month.

35 (3) All premiums shall be adjusted annually by the office of
36 financial management to reflect changes in the Washington state
37 consumer price index.

1 (4) By May 15, 2006, the board of trustees of the Washington health
2 security trust, created in section 3 of this act, shall develop and
3 implement specific rules and procedures to subsidize the health
4 security premiums of residents, including medicare eligible residents,
5 whose household incomes are less than two hundred fifty percent of the
6 federal poverty level.

7 (5) Federal employees and retirees are exempt from the health

13 voluntarily.

14 (7) Pending repeal, amendment, or waiver of applicable state and
15 federal laws delineated in section 21 of this act, native American
16 residents are exempt from paying the health security premium, although
17 the native American resident or their employer may pay it voluntarily.

18 (8) Employers shall collect the health security premiums of their
19 employees through payroll deduction. An employee may also make the
20 premium payment for a nonworking spouse through payroll deduction.
21 Self-employed and nonemployed individuals shall pay their health
22 security premiums monthly to the department of revenue. The department
23 shall assess a penalty at the rate of two percent per month, or
24 fraction thereof, on all self-employed and nonemployed individuals

(b) Negotiate with the federal department of health and human services, centers for medicare and medicaid services, to obtain a statutory or regulatory waiver of provisions of the medicare statute, Title XVIII of the federal social security act, that currently constitute barriers to full implementation of this act;

(c) Negotiate with the federal department of health and human services to obtain any statutory or regulatory waivers of provisions of the United States public health services act necessary to ensure integration of federally funded community and migrant health clinics and other health services funded through the public health services act into the trust system under this act;

(d) Negotiate with the federal office of personnel management for the inclusion of federal employee health benefits in the trust under this act;

(e) Negotiate with the federal department of veterans' affairs for the inclusion of veterans' medical benefits in the trust under this act;

(f) Negotiate with the federal department of defense and other federal agencies for the inclusion of the civilian health and medical program of the uniformed services (CHAMPUS) in the trust under this act;

1 (g) Negotiate with the Indian health services and sovereign tribal
2 governments for inclusion and adequate reimbursement of Indian health
3 benefits under the trust created in section 3 of this act; and

4 (h) Request that the United States congress amend the internal
5 revenue code to treat the employer health security assessment, created
6 in section 16 of this act, and the individual health security premiums,
7 created in section 17 of this act, as fully deductible from adjusted

23 health security trust shall further assure that community health
24 centers have appropriate referral arrangements for acute care and
25 medical specialty services not provided by the community health
26 centers.

27 (2) The (~~authority~~) Washington health security trust, in
28 consultation with the department of health, shall work with community
29 and migrant health clinics and other providers of care to underserved
30 populations, to ensure that the number of people of color and
31 underserved people receiving access to managed care is expanded in
32 proportion to need, based upon demographic data.

33 NEW SECTION. **Sec. 33.** Following the repeal, amendment, or waiver
34 of existing state and federal laws delineated in section 21 of this
35 act, all other revenues currently deposited in the health services
36 account for personal health care services shall be deposited to the

1 reserve account created in section 22 of this act and the benefits
2 account created in section 24 of this act.

3 NEW SECTION. **Sec. 34.** Nothing in this act shall be construed to
4 limit an employer's right to maintain employee benefit plans under the
5 federal employee retirement income security act of 1974.

6 NEW SECTION. **Sec. 35.** No later than January 1, 2006, the board
7 shall submit to the legislature a proposal to integrate those current
8 and future federally qualified Taft-Hartley trusts that choose to
9 participate in the trust.

10 NEW SECTION. **Sec. 36.** On or before January 1, 2007, the board, in
11 coordination with the department of labor and industries, shall study
12 and make a report to the governor and appropriate committees of the
13 legislature on the provision of medical benefits for injured workers
14 under the trust.

15 NEW SECTION. **Sec. 37.** The sum of fifty million dollars, or as
16 much thereof as may be necessary, is appropriated for the fiscal year
17 ending June 30, 2006, from the general fund to the benefits account of
18 the Washington health security trust for start-up moneys for purposes
19 of this act during the period of July 1, 2005, through June 30, 2006.

20 NEW SECTION. **Sec. 38.** The following acts or parts of acts are
21 each repealed:

31 NEW SECTION. **Sec. 39.** Sections 1 through 15, 18, 19, 21 through
32 24, and 33 through 35 of this act constitute a new chapter in Title 43
33 RCW.

1 NEW SECTION. **Sec. 40.** (1) Sections 22 through 24 of this act take
2 effect March 15, 2005.

3 (2) Sections 19, 25 through 32, and 38 of this act take effect May
4 15, 2006.

5 NEW SECTION. **Sec. 41.** If any provision of this act or its
6 application to any person or circumstance is held invalid, the
7 remainder of the act or the application of the provision to other
8 persons or circumstances is not affected.

9 NEW SECTION. **Sec. 42.** If any part of this act is found to be in
10 conflict with federal requirements that are a prescribed condition to
11 the allocation of federal funds to the state, the conflicting part of
12 this act is inoperative solely to the extent of the conflict and with
13 respect to the agencies directly affected, and this finding does not
14 affect the operation of the remainder of this act in its application to
15 the agencies concerned. Rules adopted under this act must meet federal
16 requirements that are a necessary condition to the receipt of federal
17 funds by the state.
