A message from Secretary of State Kim Wyman

Welcome to your 2017 General Election Voters' Pamphlet!

This important election features local races and measures that could have a major impact on you and your community. Voter participation data in our state shows many people only vote in the presidential election every four years. But often the decisions made in a non-presidential election year like this are more likely to impact your daily life.

Decisions made by local elected officials determine things like the time it takes first responders to get to an emergency, the maintenance of our roads, or the books our kids read in school. This year, voters will elect the officials who make these important decisions – mayors, city council members, school board directors, and fire and port commissioners. Voters will also determine the outcome of local measures and some Washington voters will vote on special legislative elections to fill unexpired terms.

For the first time since the late 1980s, there are no initiatives or referenda on the statewide ballot. However, there are various tax advisory votes on the ballot and this pamphlet contains information about these advisory votes. You'll find several pages inside designed to help you with voting and the election process.

Remember, in order to vote in this election you must be registered to vote in our state. If you are not a registered voter and want to vote in this fall's election, you have until October 30th to register at your county elections office.

By voting, you are making your voice heard as you help choose our government's leaders. Please take a moment to read through this Voters' Pamphlet, then fill out your ballot and return it by November 7th. Make an impact in your community and our state by voting this fall!

Qualifications

You must be at least 18 years old, a U.S. citizen, a resident of Washington State, and not under Department of Corrections supervision for a Washington State felony conviction.

Register to vote & update your address

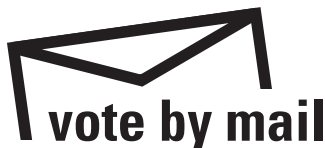
The deadline to update your voting address has passed. Contact your *former* county elections department to request a ballot at your new address.

New voters may register in person until October 30 at your county elections department.

Military voters are exempt from voter registration deadlines.

Cast Your Ballot

- 1 Your ballot will be mailed to the address you provide in your voter registration.



- 2 Vote your ballot and sign your return envelope.



- 3 Return it by mail or to an official ballot drop box by **8 p.m.** on November 7.



Where is my ballot?

Your ballot will be mailed by October 20.

Repeal or maintain?

You are advising the Legislature to repeal or maintain a tax increase.

Repeal - you *don't favor* the tax increase.

Maintain - you *favor* the tax increase.

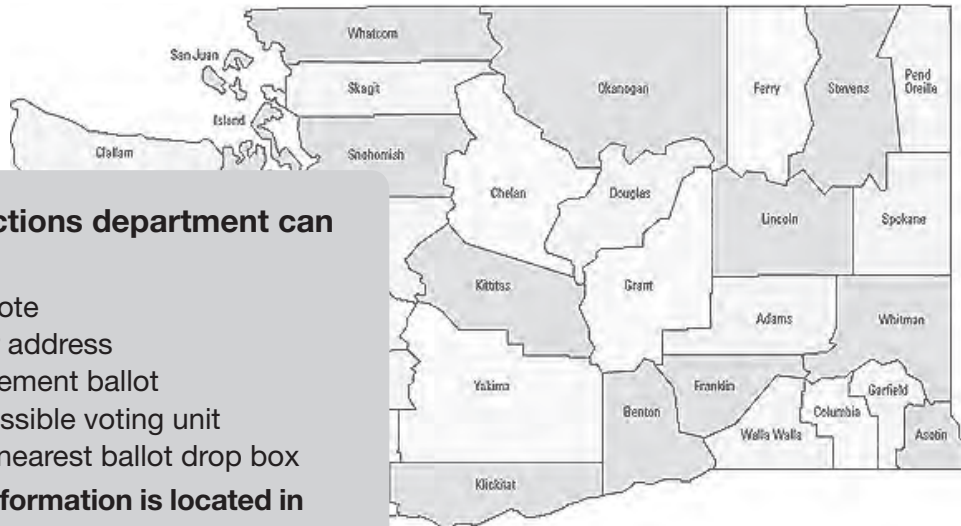

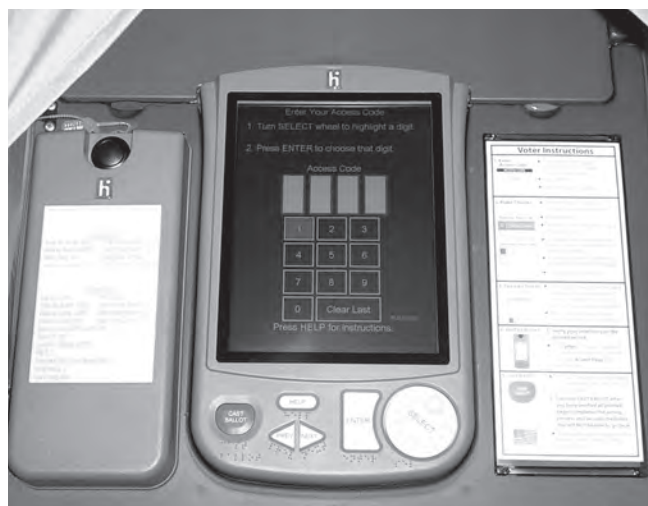
Accessible voting

Using the eSlate

Cowlitz County voters with disabilities have the option of voting independently and privately using an accessible voting unit.

The eSlate will be available Monday through Friday, during regular business hours for the General Election, beginning Friday, October 20, 2017 through Election Day, November 7, 2017.

The eSlate is a machine that allows voters with disabilities, including those who are blind, mobility impaired or lack upper-body dexterity, to vote privately and independently.

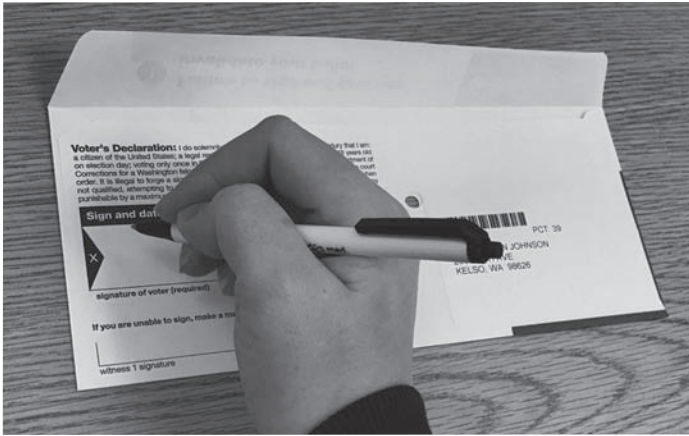

Registering to vote

Registering takes just a few minutes, and you can do it by mail, online, or in person. A Washington State driver's license or ID is required to register online. If you have moved within the same county, you can complete a new form or contact the Elections Office by mail, email, or phone.

Who is eligible to vote?

The requirements for registering to vote are simple. You must be a United States citizen, 18 years old or older by Election Day, and live within the county 30 days prior to the election.

How to vote

Washington State voters will receive their ballots by mail. If you are registered to vote in Cowlitz County, we will mail you a ballot for every election in which you are entitled to participate.

Lost or damaged ballot?

Ballots will be mailed October 20, 2017. If you don't receive your ballot by October 25, please contact the Elections Office.

Ballots will be forwarded by the post office if you have a current forwarding order.

If you have moved, please contact us to update your address.

No postage is required if you deposit your ballot in a ballot drop box. Ballot boxes are opened 18 days prior to the election and remain open 24 hours a day until Election Day, when they are promptly closed and locked at 8:00 p.m.

You can plan ahead and receive and/or return a ballot if you are out of the area at election time. Contact the Elections Office for available options.

Mailing your voted ballot on Election Day does not guarantee it will be postmarked in time to be counted. The post office recommends mailing your voted ballot the Friday prior to Election Day. Ballots with a late postmark will not be counted.

It is okay if you forget to place your ballot in the secrecy sleeve. The secrecy sleeve is an extra privacy measure, but it is not required for your ballot to be counted.



Election workers check every signature on each envelope against the signature on file for each voter. It is a felony to sign someone else's ballot on his or her behalf.

You must sign your ballot envelope for your vote to count. If you are unable to sign, you may make a mark and have two witnesses sign.

If your signature is missing or does not match the signature we have on file for you, you will receive a letter from the Elections Office. This letter tells you the reason your ballot is being challenged, and gives you the opportunity to sign and resolve the problem. Once we receive your completed form, your ballot will be processed.

Are you registered?

If you aren't, there may still be time!

Washington State residents who are not already registered to vote in Washington may register in-person at the Elections Office no later than Monday, October 30.

Note: To significantly reduce taxpayer costs, only a single version of the voters' pamphlet is mailed to every household in Cowlitz County. It is county wide and not tailored to any particular district.

Argument For

Castle Rock property owners are asked to approve a one-year levy of 50 cents per \$1,000 of assessed valuation to fund the Castle Rock Library for the year 2019. This levy would not impose an additional tax burden, but would replace the levy amount that funded the 2018 library budget.

The levy, which would again cost the owner of a \$150,000 home \$75, would enable the library to remain open 38 hours a week. It includes staff wages and operating costs. Approval would provide continued free public Internet access and informational publications such as the archived *Advocates* and E-books.

Castle Rock's library has over 21,000 volumes of fiction, non-fiction, children's books, videos, books on tape, and reference materials. Adults may take advantage of the opportunity for recreational and informational reading. No additional fee is required for City tax payers to hold a library card and anyone outside the city limits can obtain one for a nominal fee.

Children learning reading skills in school may hone those skills at the library and by participating in the summer reading program. Students can also use the library as a study resource and job seekers can access job opportunities on the Internet for free.

Not only is Castle Rock's library vital to the community, but healthy libraries are important to new businesses when they consider moving into the area. Studies have shown that library access helps to educate voters, encourages employment, and discourages crime and substance abuse.

We urge voters to approve this levy.

The City Council of the City of Kalama, Washington, adopted Ordinance No. 1387 concerning a proposition for police and public safety facilities. If approved, this proposition authorizes the City to design, construct, develop, improve and equip police and public safety facilities; issue \$2,200,000 of general obligation bonds with a maximum of 30 years to pay a portion of the costs of the project; and levy annual excess property taxes to repay the bonds, as provided in Ordinance No. 1387.

Explanatory Statement

The City of Kalama, Washington (the “City”) requests voters to approve a police and public safety facilities bond issue to construct new police and public safety facilities for the Kalama Police Department. The previous police headquarters were flooded in 2015 and since such time the Department has been temporarily operating out of the Kalama Community Building until a new police facility is built. The City has identified a potential site on City-owned property for the new facilities to be constructed. Bond proceeds will be used, together with other available funds, to design, construct, improve and equip new police and public safety facilities, including related training, storage, administration, briefing, workstation, and jail holding facilities. Without voter approval, the City does not have funding to pay for the projects.

The bonds would mature within 30 years or less and would be payable from annual excess property taxes. The cost would be approximately \$0.59 for every \$1,000 of assessed property value, costing the typical homeowner (of a \$250,000 home) approximately \$12.26 per month or \$147.07 per year. The exact amount of such annual levies for these bonds would depend on the amount of principal paid each year and on the interest rates available at the time the bonds are sold. Homeowners who are 61 years or older, disabled, and who meet low-income requirements may qualify for a property tax exemption.

Argument For

Shall the City of Kalama issue \$2,200,000 bond to finance the building of a new police station?

The flood of December 2015 damaged Kalama's already temporary police station beyond repair. The department has since operated out of the community building which does not meet safety, operational, or security requirements.

Approval of this bond measure authorizes the City to issue up to \$2,200,000 of general obligation bonds. The money will build, equip and furnish a new police station on land already owned by the City of Kalama, providing safety and security for both Kalama police and citizens at the lowest cost. Bonds will be repaid by property taxes. The City estimates the bonds will cost property owners \$0.59 per every \$1000 of assessed property value, or \$147.50 annually for a property appraised at \$250,000.

We urge a yes vote for this fiscally responsible plan that provides for your City's current and rapidly growing public safety needs.

Rebuttal of argument against

After studying multiple geographic possibilities, our Mayor and City Council proposed building a police station on city owned property that is well placed, eliminating land cost. Architects' preliminary plans helped establish pricing for a fully operational facility in order to seek bond approval, shortening the bid/build cycle and further reducing costs. This facility will meet Kalama's projected needs over the next 20-30 years. Further exploration adds expense and delays for our much-needed police station.

Vote *no* because our city council did not conduct town hall *meetings*, allowing community to review and provide input on alternatives for placement of the police station. *Location, location, location.*

Over 2 years of working on this, only one location and one \$75,000 professional architectural plan was done. There are many properties, open land and buildings, but there are few parks and city owned properties.

Town hall meetings would have identified available lots and buildings and the pros and cons of each. We have a new city hall, with an unused second floor and basement. *Any* future use of this space will require taxpayer money to properly improve. Its location provides easy access for Kalama residents, local businesses, I5, North and South, and outlying port businesses. Professional studies would provide us the true expense involved for these improvements.

Levy lid Lift for Law Enforcement Personnel and Equipment

The Woodland City Council adopted Resolution No. 689 to fund law enforcement. If approved, this proposition will fund the hire of two officers and a sergeant and their equipment. This proposition authorizes a 2018 regular property tax rate increase of \$0.7789/\$1,000, for a total estimated levy rate of \$2.8415/\$1,000 assessed value. The 2018 levy amount shall be used to calculate future levy limits.

Pursuant to RCW 84.55.050, the Woodland City Council adopted Resolution No. 689 to authorize an increase in the City's regular property levy in an amount exceeding the 1% levy lid. The lid lift is classified as a one-year permanent increase. The exclusive purpose of the lid lift is to fund and equip over multiple years two additional police officer positions and a police sergeant position.

If approved, the 2018 regular property tax rate would increase \$0.7789 per \$1000 of assessed value. The estimated total regular property tax rate would be \$2.8415 per \$1000 of assessed value.

Argument For

Staffing for the Woodland Police Department has remained unchanged since 2007! Since 2010, calls for service have increased nearly 100% as the city's population has increased 20%. The crime rate has increased over 42% in just the last 2 years. These factors have contributed to the cancelling of at least six emergency calls for service in 2016 alone.

From July 2015 to July 2017, overtime expenditures have totaled over \$350,000. The safety and health of officers are at risk. They are expected to carry a heavier workload than officers 10 years ago.

The recently formed citizen's advisory committee reported "that these staffing deficits contribute to longer response times, and problems with dealing with more serious drug, property, and violent crime in the city." They also reported that Woodland's high crime rate "is due in large part to out of area criminals picking Woodland homes and businesses as easier targets than similar entities in Vancouver or Portland."

The citizens want jobs and business to come to Woodland. Do you think Woodland will be able to attract business if reducing crime and public safety is not a priority?

The city council has failed to address this critical staffing shortage. WPD is stretched to its breaking point. They will be incapable of providing adequate services without additional personnel in the very near future. It is up to the citizens of Woodland to support the police. Demand public safety be a priority for the future health of Woodland.

Explanatory Statement

The Woodland City Council adopted Ordinance No. 1363 creating a Transportation Benefit District (TBD) pursuant to Chapter 36.73 of the Revised Code of Washington. The purpose of a TBD is to fund transportation projects.

The Woodland Transportation Benefit District adopted Resolution 2017-001 requesting approval of an increase of the tax on retail sales within the District.

If approved by voters, the measure will allow for a two-tenths of one percent [0.2%] increase in the local sales tax for ten years. The funds collected are intended for resurfacing of streets and for projects identified in the City's 6-year Transportation Improvement Plan.

Argument For

As Woodland moves forward with working on solutions for traffic congestion, especially at intersections that we are working with other levels of government, it is critical to demonstrate that we have done all we can as a city prior to looking for State and Federal dollars, and to have a dedicated account with matching funds to meet the requirements of some of these grants.

If approved, this ballot would establish a .2% sales (2/10ths of 1%) tax within the boundaries of the Woodland city limits. Woodland's sales tax rate is currently 7.9% and would rise to 8.1%, equal to Kelso and lower than Longview and Vancouver's 8.4% rate.

The sales tax will spread the costs among all user groups, including all travelers that use our roads while passing through. *The sales tax will not apply to the cost of groceries, prescriptions, gasoline, rent or mortgage payments.*

This tax is anticipated to generate \$2.7M over 10 years. This funding would be used exclusively for capital projects, pavement overlays, chip seal, and sidewalk/curb repairs.

We have huge, big-dollar capital projects such as the Scott Avenue crossing and solving Exit 21's congestion on the horizon. Let's work together to plan funding solutions for these projects, while we invite the commuters that use our roads and services to help our residents pay for them.

Rebuttal of argument against

Explanatory Statement

Passage of Proposition 1 will allow the Longview School District to address critical facility needs. This proposition will pay for the replacement of Mint Valley Elementary School, Northlake Elementary School, and Olympic Elementary School. It will also include the remodeling of Broadway Learning Center, which houses the Head Start program and the District's special education preschool program. Safety and security projects at all District schools would also be made, including but not limited to video surveillance systems, panic alarm systems, access control systems, main entry door systems, radio communications, and exterior and interior light improvements.

If approved, the District expects to receive approximately \$4,670,000 in State matching funds to complete these projects. The bonds would be repaid out of annual property tax levies. Based on current projections of assessed valuations, the levy rate is estimated to be \$0.96 per \$1,000 of assessed valuation, costing the typical homeowner of a \$200,000 median home \$16.00 per month (\$192.00/year). Tax exemptions may be available to homeowners, age 61 or older, and disabled persons that meet certain income requirements. For information, call the Cowlitz County Assessor at (360) 577-3010.

The Longview School District did a study which assumes no student growth so for \$121 million we have a plan which adds little additional class space. In addition the spending is in locations where we would not expect future population growth.

Portables should be considered a short term solution for overcrowding which should have included a board approved plan to expand the school at the location where the portables were placed. It appears the board plan was to purchase portables then later hit the voters with a bond to rebuild the whole school which is what we have for all three schools at the same time.

At present we pay Longview schools in the form of a property tax about \$4.60 per \$1000 of assessed value. If this bond is approved the tax will increase to about \$5.50 or a 21% increase. In today's tight housing market landlords will be able to pass their increased property tax cost on to their tenants.

It assumes we taxpayers will throw new money at schools when we have population growth or other changes that cause an increased need for more classroom space. This appears to be an expensive shot at immediate needs not a part of a long term problem solving program.

The Woodland Swimming Pool and Recreation District requests voters to approve a bond issue to construct a swimming pool and community center to serve residents of the District and surrounding areas. The Woodland area does not currently have a community swimming pool to serve its residents. The District has identified land in Woodland for the construction of a swimming pool and related facilities to fill this need. Bond proceeds will be used, together with other available funds, to acquire, construct, design, develop and equip a swimming pool and recreation facilities, including a fitness center, multipurpose rooms and related parking. Bond proceeds are expected to finance approximately 49% of total project costs, with the remaining funds expected to come from public grants and private sources. Bond issuance and completion of the project may be contingent on the availability of such additional funds. The bonds would mature within 20 years from the date of issuance and would be paid by annual excess property taxes. The cost would be approximately \$0.38 for every \$1,000 of assessed property value costing the typical homeowner (of a \$250,000 home) approximately \$7.92 per month or \$95.00 per year. The exact amount of such annual levies for these bonds would depend on the amount of principal paid each year and on the interest rates available at the time the bonds are sold. Homeowners who are 61 years or older, disabled and who meet low-income requirements may qualify for a property tax exemption.

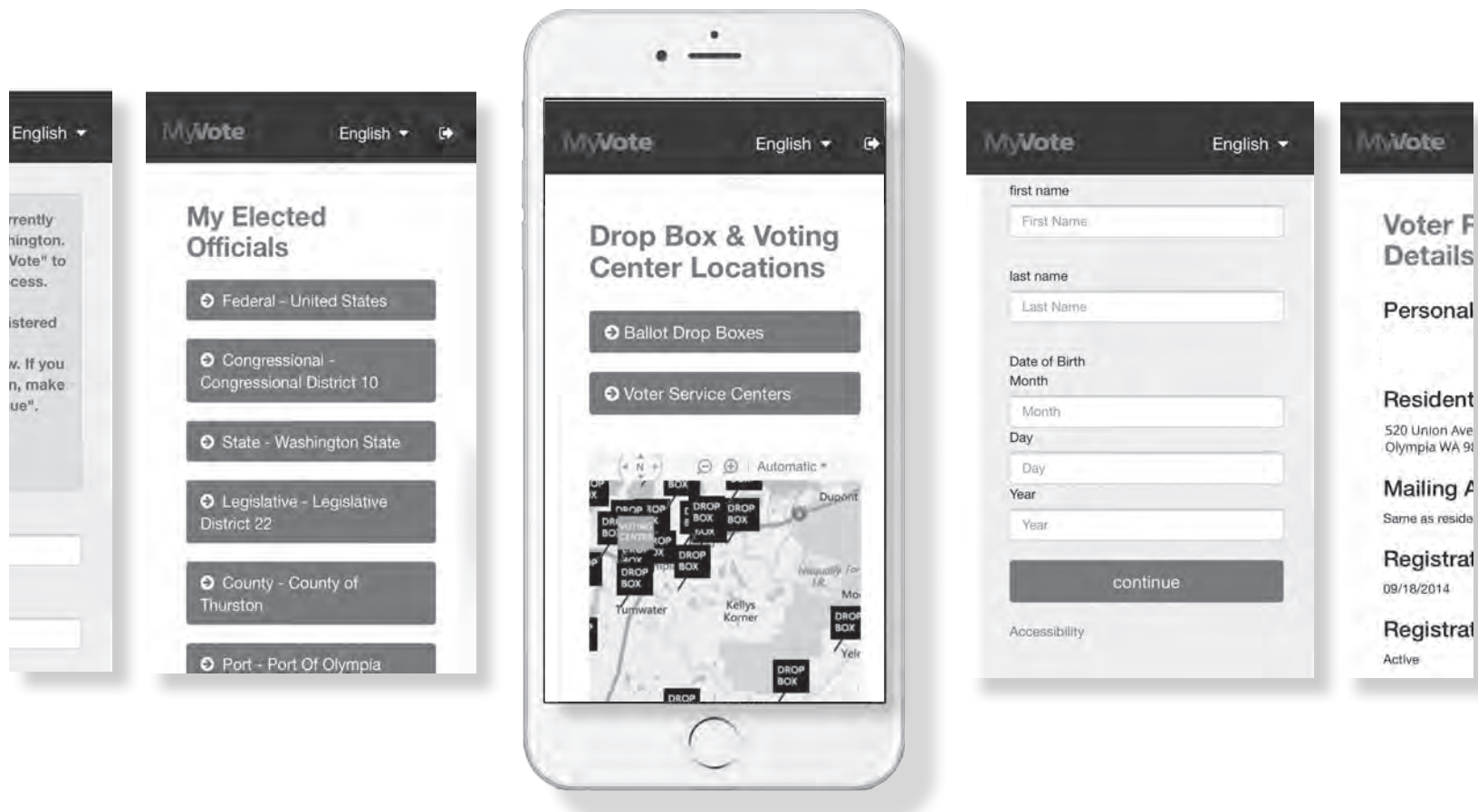

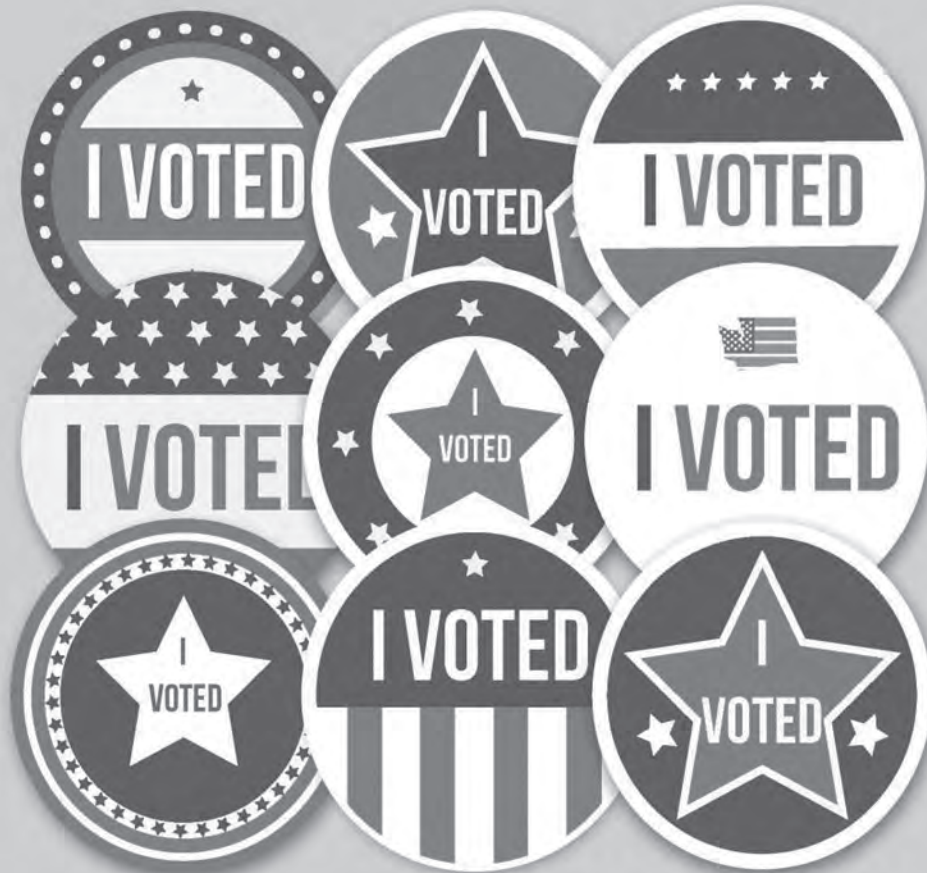

Election staff scan the envelope bar code to find your signature in the state database.



3 Your signature is verified

The signature on your ballot is compared to the signature on your voter registration record. If the signature matches, you are credited for voting to ensure only one ballot is counted for you.



If the signature doesn't match or is missing, election staff will contact you before your ballot is processed.

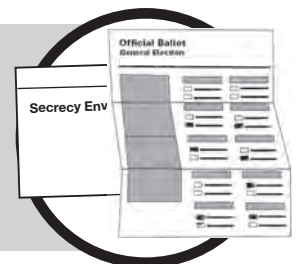
4 Envelopes are separated

The return envelope is opened and the security envelope is removed. The envelopes are separated to ensure the secrecy of your vote.



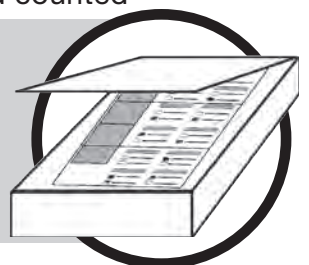
5 Your ballot is reviewed

Election staff review every ballot to verify voters followed the instructions. If a ballot can't be read by the scanner, the votes are copied onto a new ballot.



6 Your ballot is scanned and counted

Your ballot is ready to be scanned! At 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted.
