

## Summary of Changes

### ***Fire and Emergency Medical Records Retention Schedule v.2.0 (December 2020)***

#### **New Records Series Added**

- Five (5) new records series have been added to this records retention schedule:
  1. **Burning Permits – Received for Reference (DAN FM2020-010) p.10**  
*“Until no longer needed for agency business (Non-Archival)”*
  2. **Juvenile Fire Setter Assessments/Interventions (DAN FM2020-011) p.6**  
*“5 years after individual reaches age 18 (Non-Archival)”*
  3. **Pharmaceutical Inventory Accountability (DAN FM2020-012) p.4**  
*“6 years after date of administration, destruction, or return to distributor (Non-Archival)”*
  4. **Post-Incident Analysis (DAN FM2020-013) p.9**  
*“6 years after completion of analysis (Non-Archival)”*
  5. **Ride-Along Program (DAN FM2020-014) p.6**  
*“3 years after participant’s ride-along and 3 years after participant reaches age 18 (Non-Archival)”*

#### **Retention Changes**

- Eight (8) records series have changes to their retention period/cutoff:
  1. **Building Information – Pre-Incident Planning (DAN FM53-04-04) p.10**  
Decreased from “Life of building (Archival – Appraisal Required)” to “Until obsolete or superseded (Non-Archival)”  
*Rationale: The information needs to be current in order to fulfill its primary purpose of facilitating emergency response.*
  2. **Burning Permits – Issued/Enforced by Agency (DAN FM 53-04-06) p.10**  
Increased from “3 years (Non-Archival)” to “6 years after expiration/revocation/denial of permit (Non-Archival)”  
*Rationale: To align with retention requirements for permits issued by Department of Ecology and other agencies with authority to issue burning permits.*
  3. **Fire Incident Reports (DAN FM53-04-14) p.7**  
Changed from “6 years (Non-Archival)” to “6 years after end of calendar year (Non-Archival)”
  4. **Fire Investigations – Incidents That Result in Loss of Human Life (DAN FM53-04-17) p.8**  
Changed from “6 years after conviction *or* 10 years after decision not to proceed with investigation (Archival – Permanent Retention)” to “6 years after conviction and exhaustion of appeals process *or* 10 years after decision not to proceed with investigation (Archival – Permanent Retention)”

5. **Inspection/Testing of Firefighting Apparatus and Equipment (DAN FM53-04-18) p.5**  
 Changed from “Life of equipment (Non-Archival)” to “Life of apparatus/equipment (Non-Archival)”
6. **Medical Incident Reports (DAN FM53-04-20) p.7**  
 Changed from “8 years after provision of services (Non-Archival)” to “8 years after provision of services and 3 years after individual reaches age 18 (Non-Archival)”
7. **Radio Logs (DAN FM53-04-23) p.7**  
 Changed from “90 days (Non-Archival)” to “90 days after date of document (Non-Archival)”
8. **Remittances to Volunteer Firefighters’ and Reserve Officers’ Relief and Pension Fund (DAN FM50-03A-37) p.11**  
 Changed from “6 years after retirement of last item (Non-Archival)” to “6 years after end of fiscal year (Non-Archival)”
